Approval of Minutes: Blue Corneliusen asked the Board Members if there were any questions or comments regarding the Minutes of March 18th, 2024, Board Meeting, Lori Zeiser moved to accept the minutes as written, Dennis Schwecke second, all Board Members in favor of, motion passed.

Public Comments: No public comment.

OLD BUSINESS

Drinking Water Upgrade Project: Blue Corneliusen stated he spoke with Dan Richardson of KLJ Engineering, will be ready to go out for bid upon DEQ approval, would like to hold a public meeting after approval received. Sarah Converse with Sweetgrass Development handed out paperwork for the first draw from ARPA, waiting on paid copies of invoices to KLJ Engineering by the Sun Prairie County Water District, then would get submitted. Blue Corneliusen provided update on the March 19, 2024, Teams meeting, and next monthly teams meeting to be held on Tuesday, April 23, 2024, from 2:00 PM to 2:30 PM.

WATER OPERATOR'S REPORT: Arron Pomeroy provided a verbal update on the drinking water and irrigation system; generator was repaired, pressure relief valve installed, still waiting irrigation pump. March 2024 Average Daily Water Consumption 18,539 Gallons, Total Monthly Water Consumption 574,700 Gallons; Average Daily Chlorine Residuals: Injection Point 0.66, Distribution Locations 0.33.

TREASURER'S REPORT: Bank Balances as of March 29th, 2024: Checking \$35,572.06, Savings \$25,022.15, Construction \$0.00. Accounts Receivables Delinquent as of April 15th, 2024, provided to the Board, as well as Balance Sheet and Profit/Loss.

PRESIDENT'S REPORT: Blue Corneliusen asked for the Board to review again the Rules and Regulations for approval at next board meeting; still working on the S.O.P. Manual; continuing to work on a 2024 Annual Budget which the District may have to raise the irrigation rates due to using drinking water funds for repairs to irrigation; still discussion on holding a public meeting in the near future to discuss the Water Upgrade Project; Board had interviewed Paul Finco for the open board seat after the last meeting to which will appoint at the May meeting; irrigation to begin May 15 and posting to Facebook and website regarding start up with Odd/Even days irrigating; Rural Water Impact & Municipal Impact provided website estimate and flyer, to which Lori Zeiser moved to accept the estimate of \$898.00 for a new website with alert system, Dennis Schwecke second the motion, all members in favor of, motion passed.
